

STOP THE DESECRATION OF GLEN COVE

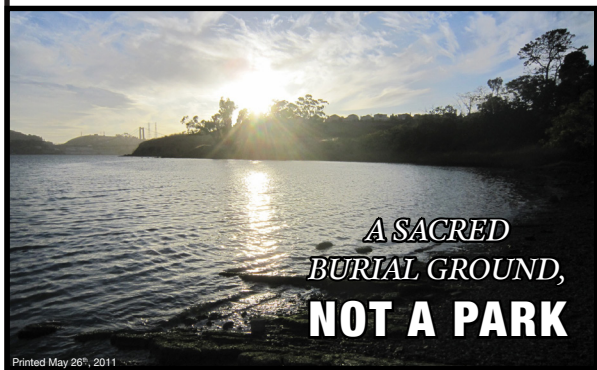
{ A sacred Native American burial ground in Vallejo, CA }

GLEN COVE is a sacred gathering place and burial ground, utilized by numerous Native American tribes since at least 1,500 BC. The Greater Vallejo Recreation District (GVRD) has for years been pushing forward a proposal to develop this site into a public park, reconfiguring/grading the land and adding a paved trail, bathrooms, and a parking lot. All along, the voice of Native people has been loud and clear in regards to this spiritually significant place: NO DEVELOPMENT where the ancestors rest.

ON APRIL 15TH, NATIVE AMERICANS ESTABLISHED a spiritual encampment and prayer vigil at Glen Cove, blocking GVRD from carrying out their planned desecration. While many strategies are being pursued to establish protection for Glen Cove, the encampment stands as a front line of defense. At this time GVRD is still pursuing park development, and support is needed more than ever.

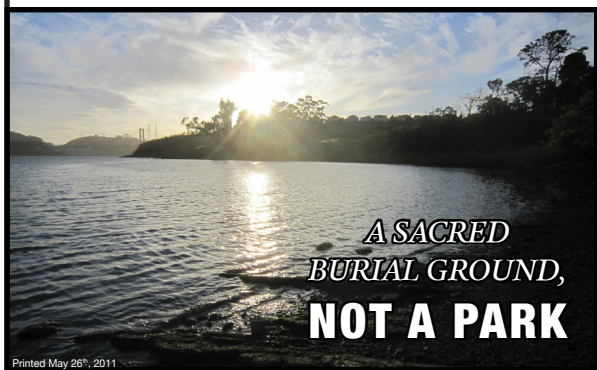
