RESOLUTION NO: 11-05-03

DATE: May 24, 2011

SUBJECT: Resolution of Support for protection and preserving Glen Cove Shellmound Burial Site

WHEREAS: The Pit River Tribe is a Federally Recognized Tribe composed of eleven autonomous bands located in northeastern California, since time immemorial, AND

WHEREAS: The Pit River Tribal Council is empowered by Article VII of the Constitution, to enact all ordinances and resolutions which shall be necessary and proper for carrying into effect the Council's powers and responsibilities, to contract with Federal, State and Tribal governments, private enterprises, individuals and organizations, AND

WHEREAS: The Pit River Tribe is governed by the Pit River Tribal Council, the body duly elected, under the Constitution of the Pit River Tribe in 1964 and duly adopted on August 16, 1987, and approved by the Assistant Secretary of Interior, for Indian Affairs, December 3, 1987, AND

WHEREAS: The Pit River Tribe has been active and deliberate in the protection of indigenous, traditional, religious, and cultural sites inherent in our sovereign Nation, AND

WHEREAS: The Tribe acknowledges the Glen Cove Shellmound Burial Site (aka-Glen Cove Waterfront Park) as a sacred site that must be protected and preserved for its historical, cultural and religious value, AND

WHEREAS: The Greater Vallejo Recreation District (GVRD) and the City of Vallejo are currently purposing to develop a park with trails and amendments that would desecrate the Glen Cove Shellmound Burial Site, AND

WHEREAS: The Tribe supports preserving this sacred and historic site, NOW

**NOW THEREFORE BE IT RESOLVED**, that the Pit River Tribal Council hereby acknowledges the Glen Cove Shellmound Burial (aka-Glen Cove Waterfront Park) a sacred site, and deserves the respect and protection for future generations.
